V. FINANCIAL REPORT

- b. Runk notes the significant increase in the per horse fees from the Northern Winter Classics versus in 2020
- c. Runk adds that both individual memberships and horse memberships are increased from last year at this time

VI. NEW BUSINESS

- a. Increase membership fees for 2022 (Borges)
 - i. Borges notes that membership fees seem low compared to other organizations
 - ii. Lampton confirms last fee increase was in 2018
 - iii. Borges notes that if a vote is made for an increase this year, the increase would not take effect until 2022 but time is needed to update the website and membership forms if vote were to pass
 - iv. MOTION: Increase membership fees as follows:
 - 1. Horse-annual \$50
 - 2. Individual-annual \$65
 - 3. Horse-life \$120
 - 4. Individual-life,\$650
 - 5. Individual- 3 year \$180
 - v. 1st VOTE: 11 in favor, Rattigan abstains

 - i. Old: The winners of the NorCal Junior and Senior Medal Finals are no longer eligible to compete in the NorCal Medal Class. Juniors may, however, compete in the Senior Medal Class when they move up to the Amateur division.
 - New: (Junior) The winners of the NorCal Junior Medal Finals are no longer eligible to compete in the NorCal Medal Class. Juniors may compete in the Senior Medal Class when they move up to the Amateur division.
 - iii. New: (Senior) The winners of the NorCal Senior Medal Finals are no longer eligible to compete in the NorCal Medal Class for the next 7 years following their win.

- b. NorCal Senior Finals may be combined with Jr (Lampton)
 - i. Old: Beginning in 2016, if there are fewer than eight entered finalists in the NorCal Senior 3'6" Medal Finals the final for Juniors and Seniors will be combined.
 - ii. New: If there are fewer than eight entered finalists in the NorCal Senior 3'6" Medal Finals the final for Juniors and Seniors may be combined.
